Throughout history, it is always fascinating to see the ways in which radical yearning has been and can be lived out, and the ways in which lives can be fully expressed in the interaction between yearning and love. 





Inspired by R. Bultmann's program of demythologization, this text inquires into the truth of mythical images in the Bible. It examines the various ways in which the Bible talks about God: narratively, dialogically, and doxologically, as well as ethically, mystically, and metaphysically. The Bible interprets Christological imagery as a kerygmatic message that leads to confrontation with God, as poetic imagination that seeks existential fulfilment, as a world of social symbols that creates sacred communal spaces. The 'demythologization' of this symbolic world starts with faith in the Holy Spirit: the cross reveals our distance from God, and the mystery of Easter renews God's nearness to us as a resonance in human beings through the Spirit. After 80 years, Bultmann's programme of demythologization is in this way renewed and continued kerygmatically and poetically, existentially and socially, cosmically and mystically. The concern remains the same: to decipher the message of the Bible through its mythical images.







This commentary regards Jer. 1-25 as a dramatic text: in laments, accusations, and predictions of disaster, it issues a polyphonic message on the downfall of Jerusalem and Judah. In accordance with the format of this series, the Hebrew text is initially analysed synchronically in relation to rhetoric, genre, linguistic phenomena, motifs, and theological statements. Against the background of the political situation of Judah from the end of the seventh century BCE, a diachronic analysis attempts to reconstruct the genesis of the text. The starting point for this is the older version of it, preserved in the Greek tradition. The texts, which are rich in imagery and sometimes disturbing, and which set the scene for the downfall of the kingdom of Judah, are interpreted by Maier for contemporary readers with the help of more recent hermeneutical viewpoints such as feminist biblical interpretation, postcolonial theory and trauma research. The way in which the book of Jeremiah seeks to come to terms with cultural trauma - and in the face of war, famine and expulsion, struggles to find an image of God that is capable of explaining history, while at the same time conveying hope for a better future - becomes clear in the process. The female personification of Jerusalem provides an emotional and compassionate portrait of the people, giving voice to their experiences of the violence and destruction of war. Jeremiah, persecuted for his message of doom, is wrestling with God on behalf of the people.







In the fifth and sixth centuries before Christ, people in Greece begin to think in a new way about the origins and primal causes of the world. We regard this thought today as representing an initial form of philosophizing. It was only hesitantly that it freed itself from its traditional ties to mythology, in which the genesis of the world is conceived of as a theogony. In the process, however, it laid its own foundations, on which our thinking is still based today. This also involves increasingly viewing the divine foundation of the world as a natural foundation, and identifying within it the foundations of our own thinking. This account rethinks the beginnings of philosophical thought on the basis of

its own presuppositions. It traces developments from Thales to Democritus and places them in relation to each other. One difficulty with this process is that later thought has been superimposed on the initial stages, so that the views of the so-called 'Pre-Socratics' have been transmitted in only a fragmentary and patchy way.


